- Multifactor authentication



2019 Highlights: Functionality

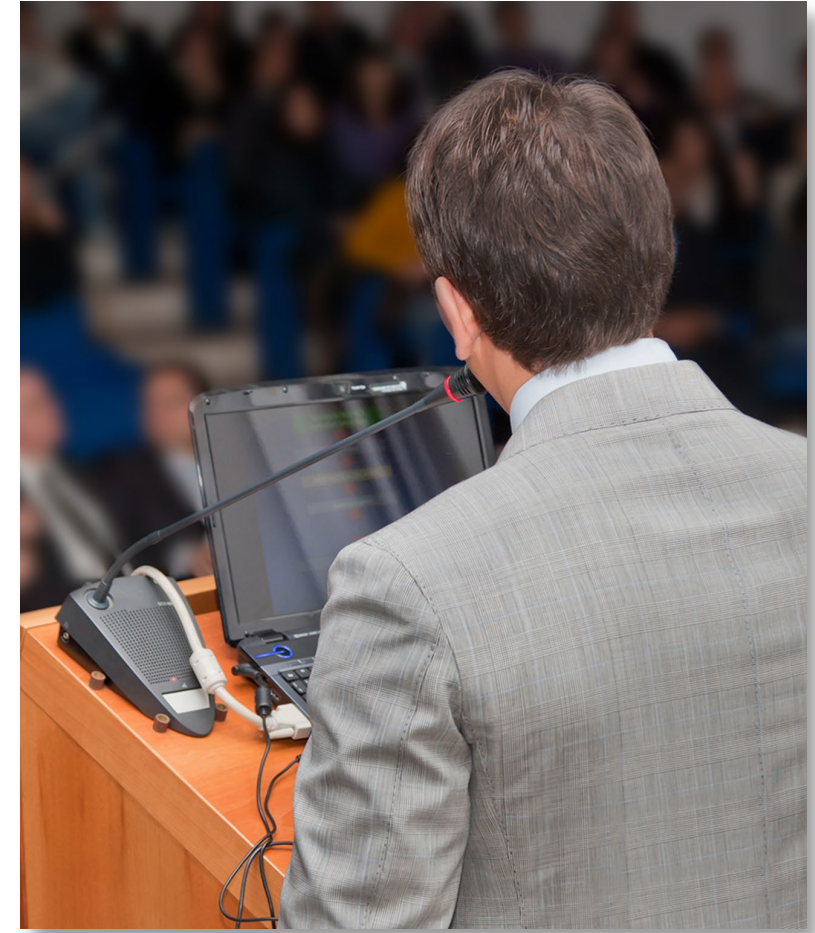
- Legacy billing systems functionality were implemented in SCEIS.
- State Treasurer's Office check printing transitioned to a third party vendor.
- Collaboration with the Department of Health and Human Services resulted in provider payments and vendor data being processed in SCEIS.
- Implemented the Flexible Real-Estate Management Module.

2019 Highlights: Legislative Mandates

- The Department of Aging, The Department of Children's Advocacy and the Department of Veterans Affairs were established in SCEIS.
- Over 1.28 million Lottery rebate payments were processed and distributed.
- Configured human resources hard stops and transactional warnings to support statewide data consistencies.

2019 Highlight: User Outreach

- Partnered with the User Group Leads Committee to reinstate quarterly meetings.
- Completed a SCEIS rebranding project to enhance visual communications and alignment with the Department of Administration (Admin) identity.
- Streamlined communications through a new bimonthly user updates schedule.



2019 Highlight: User Outreach

- Created videos to offer clear and concise communications regarding the multifactor authentication process.
- Offered three new online classes for convenient user learning.
- Initiated alliances with agencies that expressed need for Admin services related to SCEIS processing.
