Effective Monday, Sept. 25, 2023, the following changes will be made to the State Fiscal Accountability Authority (SFAA) purchasing groups (P-Groups) in SCEIS:

- ITMO-Acquisition Manager 600 will no longer exist.
- MMO-Acquisition Manager 500 will be renamed to SFAA/PSD-Acquisition Manager 500.

Users who need to redistribute a requirement (shopping cart) to SFAA and users who were previously listed under ITMO and MMO **must use SFAA/PSD-Acquisition Manager 500** beginning Monday, Sept. 25, 2023.
