- 1. NO changes for FY2020
 - ✓ Winter is coming for operating leases but not yet!
 - ✓ GASB 87 will be implemented for South Carolina beginning 7/1/2020 (FY2021)
 - ✓ No early implementing!
 - ✓ ALL leases entered into during FY2020 must be accounted for under <u>current</u> GASB standards
 - Beginning in FY2021 almost ALL leases will be classified as capital leases per GASB 87
 - ✓ Capital leases are essentially treated as a financing arrangement and the leased items as assets.

- 2. Leases from vendor Presidio Technology LLC
 - Under <u>current</u> GASB requirements, all leases containing a bargain purchase option must be accounted for as a capital lease as opposed to an operating lease.
 - The current statewide procurement contract with Presidio Technology Capital LLC to provide IT and copier equipment contains a bargain purchase option, therefore <u>ALL</u> IT and copier equipment leased under this contract/vendor must be accounted for as a capital lease.
 - ✓ The state contract with Presidio began on 2/8/2017 and runs through 2/7/2024.

- 3. Overview of Capital Lease Accounting high level example showing the steps for the accounting of a capital lease from Presidio:
 - 1. Enter into a copier lease with Presidio.
 - 2. Create an amortization schedule showing the monthly split between principle and interest or a copy can be found within the Presidio contract.
 - A copy should be attached to the PO as well to the vendor invoice payments
 - 3. Create an asset for the copier in SCEIS using transaction code AS01
 - Make sure to complete the Leasing tab
 - 4. Capitalize that asset using SCEIS transaction ABZON
 - 5. Create the shopping cart
 - In the Account Assignment tab, at least two lines should be created: one for principle and one for interest
 - G/L 5041820000 CAP LEASE PRINCIPLE PAY-EQUIP
 - G/L 5041830000 CAP LEASE INTEREST PAY-EQUIP

- 6. Create the purchase order
 - Note: the asset is not on capital lease PO's
 - Important: select PO document type ZCAP Capital Lease PO
 o ZCAP PO's follow the same methodology as blanket PO's
 - Again, the PO will have at least two lines: one for principle and one for interest
- 7. Pay monthly lease invoices from Presidio
 - While the periodic payment remains the same, the split between principle and interest will change with each payment based on the amortization schedule.
 - A/P approvers should be ensuring that there are at least two lines for each Presidio lease invoice one for principle and one for interest:
 - G/L 5041820000 CAP LEASE PRINCIPLE PAY-EQUIP
 - G/L 5041830000 CAP LEASE INTEREST PAY-EQUIP
 - A copy of the amortization schedule should be attached as supporting documentation

Additional Notes for Presidio Leases

- Unless you are purchasing equipment outright from Presidio (not common), the PO document type used should be ZCAP Capital Lease PO. This allows the agency to change the split between principle and interest for each payment (similar to a blanket PO).
- This may seem like a hassle to go through all of this extra work for one particular vendor but this is actually very good practice for agencies to prepare for the implementation of GASB 87 LEASES which for South Carolina will begin for FY2021 i.e. starting July 1, 2020.
- As noted above, under GASB 87 almost all leases will be considered capital leases. It will be uncommon for an agency to have an operating lease once this new pronouncement goes into effect. This will impact ALL state agencies.

- 4. Submitting Copies of Lease Contracts to the CAFR Group
 - Presidio leases are provided to the CAFR team monthly by MMO.
 - Capital leases with vendors other than Presidio should be sent to the CAFR team and an asset created before the first payment is made.
 - Copies of ALL contingent operating leases as well as leases with future payments should be submitted with your Operating Lease closing package on August 23rd

- 5. How will current operating leases be converted to capital leases in SCEIS?
 - ✓ This is still being researched.
 - ✓ It may be possible that one or a combination of upload templates can be used to create the assets.
 - Even if upload templates can be used agencies would have to complete all of the fields for each lease / asset.
 - Additional information and instructions will be sent out later in the fiscal year.

- 6. Capital lease training classes
 - Information regarding training opportunities will be sent out soon.
 - ✓ The CG's Office will work with SCEIS and a combination of training classes, written guidance and meetings will likely be utilized.

 - ✓ We took all of the existing 504XXXXXX G/L's that are not capital lease related......

Capital Lease Accounting: FY2020 versus FY2021

Please note: these updated names do NOT change the way these G/L's are used by the agencies. If you were already using one of these G/L's you should continue to do so for FY2020. For FY2021 we will be changing all of these definitions as needed to account for the new leasing rules.

These name changes are a step to make a clear distinction between operating leases and capital leases. So high level – we will expect to see these G/L's continue to be used in FY2020. It's in FY2021 that there should be little to no activity in these G/L's as just about all leases will be accounted for as capital leases once GASB 87 is implemented.

II. General Ledger Changes for FY2020

The four G/L's to be blocked beginning in FY2020 are non-IT G/L's that include expenditures that should instead be captured within the IT range of G/L accounts:

5020130000	DATA PROCESSING SVCS - STATE	This G/L to be blocked beginning in FY 2020. Agencies should be using IT G/L 5020077240.
5040020000	RENT-COPYING EQUIPMENT	This G/L to be blocked beginning in FY 2020. Agencies should be using IT G/L 5040027000.
5040020001	RENTAL-HIGH SPEED DUPLICATING EQPT	This G/L to be blocked beginning in FY 2020. Agencies should be using IT G/L 5040027000.
5040030000	RENT-DATA PROC EQUIPMENT	This G/L to be blocked beginning in FY 2020. Agencies should be using IT G/L 5040037000.

Recovery Audits – Accounting for Vendor Credits

When the recovery is received as a <u>check</u> there are generally 3 steps:

- Deposit: the check is deposited and recorded to G/L 4530210000 REFUND FROM RECOVERY AUDIT in Fund 38K80000
- Invoice: the agency will receive an invoice from the recovery audit vendor that will be paid using G/L 5021580000 – RECOVERY AUDIT SERVICES in Fund 38K80000
- 3. Remit/Retain: depending on what fund the original expenses were recorded out of, the agency either retains the *net recovery* (recovery less amount paid to the recovery audit vendor) and transfers that cash to an agency fund OR it is remitted back to the State by transferring the remaining cash to Business Area F010 in Fund 38K80000

FY2019 Recovery Audit – Agency Accounting Guidance

Accounting for the Recovery If Received as a Vendor Credit Rather than a Check

The vendor credit would be entered into the system like normal and would be applied against current/future invoices. In order to account for that credit in the recovery audit fund a journal entry needs to then be recorded.

Example: \$1,000 vendor credit is issued and applied to outstanding vendor balance. The original invoice had been coded to G/L 5030010000 – OFFICE SUPPLIES with fund 10010000.

- Journal entry to account for that recovery in the recovery audit fund:
 - DR 5030010000 OFFICE SUPPLIES (offsets credit memo) Fund 10010000
 - CR 4530210000 REFUND FROM RECOVERY AUDIT

- The journal entry to remit that net recovery* would be recorded once the recovery audit vendor is paid their fee** (in this case the recovery goes back to the State since it was originally paid out of 10010000):
 - DR 6200010000 TRANSFER OUT Business Area XXXX Fund 38K80000
 - CR 6100010000 TRANSFER IN Business Area F010 Fund 38K80000

* Net recovery = recovered amount less fee paid to the recovery audit vendor
 ** The invoice should be coded to G/L 5021580000 – RECOVERY AUDIT SERVICES to fund 38K80000

IV. NIGP Code Mapping



NIGP Code Mapping

- The last time a full review of NIGP codes took place was right around the same time that the real estate and IT G/L's were established (a few years ago). A lot has changed since then!
- Out of 8,717 NIGP codes, 5,587 are currently mapped to a G/L account in SCEIS.
- I recently checked and out of the 5,587 currently mapped in SCEIS, 1,366 are mapped to G/L's that have been blocked for posting.
- A full review of all NIGP codes is very time consuming and requires the input and approval from several agencies. We're not sure when another full review will be scheduled.
- Remember: when entering a shopping cart the G/L CAN be changed from what gets populated by the NIGP code.
- In the meantime, if you see a code that looks to be mapped incorrectly or that you feel should be unmapped, please submit a SCEIS Help Desk Ticket. The ticket will route to me and I will work with the SCEIS Logistics group to review.
- We'll try to group these changes and push them through periodically. These are not simple changes. They have to be done after hours when the system has been taken down.
